Stallion Service Contract

Please read and fill out contract completely

- 1) The Mare Owner will pay a breeding fee of \$_____ payable as follows:
 - a) A Booking Fee of \$350.00 payable with this contract. **The Booking Fee is non-refundable**
 - b) **The balance of the Breeding Fee \$_____ and all unpaid board and veterinary fees must be paid in full before the mare and/or colt is released to the owner.**

Famous Lane Farm will have a lien on the mare, foal, and recipient mares for all unpaid bills. Past Due Accounts will bear 18% interest until paid.
- 2) The Mare Owner will pay a boarding fee of \$_____/day wet, \$_____/day dry. Boarding fees and veterinary charges are due and payable monthly upon receipt of invoices.
- 3) The mare must be halter broke, healthy and in sound breeding condition.
- 4) The Mare Owner agrees to allow **Famous Lane Farm** to have a qualified Veterinarian check the mare for normal breeding conditions and, if necessary, treat her as required for her condition.
- 5) **Famous Lane Farm** will provide and supervise treatment for the mare and/or foal for anything that appears likely to affect their well-being, including but not limited to de-worming, treating for infection, hoof-trimming and any disease preventative measures. The Mare Owner is responsible for all these charges.
- 6) The Mare Owner agrees that **Famous Lane Farm** will not be responsible for accident, sickness, or death of the mare and/or her foal. **Famous Lane Farm** will exercise judgment in the care and supervision of the mare and/or colt. It is also understood that the Mare Owner will not be responsible for any disease, accident, or injury to the **Famous Lane Farm**' Stallions.
- 7) **Famous Lane Farm** agrees to diligently try to settle the mare. If however, the mare does not settle, the Mare Owner will hold **Famous Lane Farm** harmless.
- 8) A live foal is guaranteed from this service. If the foal does not stand alone and nurse, and **Famous Lane Farm** is satisfactorily notified by a statement from an approved veterinarian within one week from the day of foaling, or if a pregnancy examination conducted by an approved veterinarian at the end of the breeding season reveals that the mare is not in foal, the Mare Owner will be entitled to a refund of the breeding fee, less the booking fee, or a return breeding the following year only at **Famous Lane Farm**' discretion.
- 9) It is further agreed, that should the above stallion die or become unfit for breeding, then this contract shall become null and void, and the breeding fee, less the booking fee, shall be refunded.
- 10) A copy of the mare's registration papers (and lease agreement, if applicable) must accompany this contract.
- 11) The contract shall not be assigned to or transferred by either party, without the expressed consent of the other party.
- 12) This agreement shall be binding upon both parties when executed by the owner on behalf of **Famous Lane Farm**.
